## Important Litigation Involvement

- Defended multiple public nuisance and environmental exposure claims centered on a wood products facility. Tanya cross-examined the opposing expert epidemiologist at a *Daubert* hearing, resulting in exclusion of the expert and dismissal of the cases. She successfully defended the appeal of the dismissals before the Seventh Circuit. *Pecher, et al. v. Owens-Illinois, Inc.*, 859 F.3d 396 (7th Cir. 2017).
- Trial experience, including seven day, federal court jury trial resulting in a verdict in favor of the client, which included punitive damages and attorney fees. The verdict and fee award were upheld by the Fifth Circuit. See *Ill. Cent. R.R. Co. v. Guy*, 682 F.3d 381 (5th Cir. 2012). The U.S. Chamber of Commerce awarded Forman Watkins with the Institute for Legal Reform's Award for Outstanding Organization, in part, for its efforts in this case.
